**Conditions of the Agreement:**

- At least two puppies whelped alive constitutes a litter. In the event of a litter containing only one puppy, the owner of the of the bitch is entitled to keep said puppy at no additional costs.
- If no pregnancy results, a free service will be given at the next heat of the same bitch and to the same stud, or to another stud, if mutually agreed upon.
- If the stud dog is no longer available, an extension of the time necessary to fulfill the stud agreement will be given of two calendar years, and another stud dog (also *owned by the owner of the current stud dog*) must be selected.
- No refund of stud fee will be given if there is no pregnancy resulting from either attempt.

- Owner of the stud will sign the litter registration application upon clearance of payment for the stud service. If other terms are included in lieu of payment, these terms must be fulfilled before the application will be signed.
- No type of boarding costs will be charged, as long as the bitch is picked up within 2 weeks following notification of the end of her heat cycle. Otherwise, a rate of \$10/day is required at the time of pick up.
- Any and all transportation expenses for the bitch are the responsibility of the owner of the bitch.

**Owner of the Bitch Agrees:**

- No puppy resulting from this mating will be given or sold to any person or establishment dealing in the wholesaling or retailing of dogs or animals.
- All pets (not conforming to the AKC standard) resulting from this breeding will be sold on limited registration.
- The bitch is healthy, free of any communicable diseases, and is current on all vaccines.
- The owner of the bitch will be responsible for any type of veterinary care that may be required during the stay of the bitch, as well as after her stay, even if it is suspected that the bitch was exposed to any sort of disease, parasite, or even an Act of God during transport, or while visiting the residence of the stud dog owner.
- If any verified hereditary health defect should be present in any of the resulting puppies, the stud dog owner should be notified, as a courtesy.

**Enforcement:** If any suit or action shall be instituted to enforce or interpret this agreement, the prevailing party shall be entitled to recover from the losing party, in addition to statutory costs, such sums as all courts may adjudge as reasonable for the prevailing party's attorney fees in such suits, actions, or an appeal thereof in Clarion County, Clarion, PA, USA.

Any changes to this agreement must be done so in writing.
