

Jalerran Stud Contract – Preliminary Checklist

About the OWNER of said bitch:

- ✓ **Ethical/Reputable** – as defined here:
 - Completes OFA/ACVO screenings
 - Does not breed “for color” or “for profit”
 - Appropriately screens homes into which puppies may be placed
 - Educates prospective homes about the breed traits
 - Offers a written health guarantee and/or bill of sale
 - Breeding goals are to closely adhere to the breed standard
 - Takes dogs back or assists in rehoming when homes cannot keep their puppy/dog
 - Bonus: “Breeder of Merit” and/or Parent Club Member
 - **ACTIVELY** participates in a recognized sport/competition – **not negotiable**
 - *Actively* doesn’t mean you plan to attend a show *some day*
 - *Actively* doesn’t mean that you ‘*went one time while at band camp*’
 - *Actively* means that your dogs are usually titled, or well on their way to titles
 - Sorry, our dogs are not available at stud to anyone who “*just wants to have a litter*”

- ✓ **Relationship** –
We want to *know* people who want to access our fur-men at stud. Here are some possible scenarios:
 - Someone who comes *highly recommended* from someone with whom we work closely
 - Someone who is willing to take the time to allow us to *get to know you before* we agree to allowing access to any of our furry-guys
 - Someone who is willing to keep in touch with us regarding any offspring out of our stud dog
 - Someone who already owns/co-owns with us

- ✓ **Prepared** –
 - Can provide vet references & has access to a 24-hour emergency vet
 - Has the funds necessary to ensure mom and puppies receive proper care
 - Has the time to be able to oversee whelp and adequately socialize offspring
 - Has a thorough screening process for prospective homes
 - Though one can probably never be over-prepared, we expect that this is not a whim

About the prospective bitch:

- ✓ **Health** –
 - Has a documented OFA of ‘good’ or ‘excellent’
 - Has an ACVO or CERF screening within the past year
 - Has a current negative brucellosis test
 - Has current vaccines & a negative fecal
 - **PREFERABLY** – has successfully been bred & whelped a litter in the past
 - Note: If her first breeding, further discussion will need to occur
 - Is otherwise in good overall general health



Show History –

- If she is not an American Champion, please explain her showing history
- Be able to outline her strengths and weaknesses, according to the breed standard
- If she is not an American Champion, please thoroughly describe her temperament, especially as it relates to being in new places, if she is to come here for a breeding
- Provide a copy of her pedigree
 - **Note:** Must be AKC ‘Full’ registration in order to show and register offspring. Sorry, we are preservationists. Therefore, our Champion or Champion-sired dogs are not available at stud for other breeds of dogs, nor to a bitch without said registration type.
 - **Note:** ‘Designers’ - If you are someone who wants to create a legitimate and AKC recognized brand new breed, and wish to use one of our dogs in the foundation stock, please be expected to provide a TON of information about that process, with the understanding that it is highly unlikely that you’ll be able to provide us with a *convincing justification* as to why you’d want to include a Siberian into your new breed.



Pairing –

- Is able to articulate what it is about the stud dog that would make him a good complement
 - **Note:** “Because he is titled” or “Because he has a cool color” are not acceptable answers
 - **Note:** We are happy to review strengths/weaknesses with qualified inquirers 😊.

Administrative Content:



Contract – please see below:

- We do generally use contracts for most interactions



“Service” – as defined here:


- You are paying for a stud “service”, meaning the opportunity for your bitch to be bred
- Unless other arrangements have been made, the stud fee is payable up front – not once you see if it took
- One puppy constitutes a litter, by definition. If no puppies result, you get to try again.
- You’re responsible for vet costs, to include that for any changes of her condition while in our care
- We are not responsible for any Acts of God
- If the heat is irregular or weak, you may need to pay for progesterone testing and/or opt to use a different bitch



Frozen or Fresh Chilled –

- Please request alternative contract for frozen or fresh-chilled
- You would be responsible for all related costs and fees, in addition to the stud fee
- You’re purchasing the semen only, without guarantee of success

Agreement

This document verifies the following agreement between Jalerran Siberians (Stud Dog Owner) and the Owner of the Bitch. All changes to this binding contract must be done so in writing. Failure to comply with the components of this agreement may result in legal action to take place in Clarion County, Clarion, PA.

The fee for this stud service is: \$2,000 USD to be paid in full at or before the time of the service.

Conditions of the Agreement:

- At least one puppy whelped alive constitutes “a litter”. In the event of a litter containing no puppies, the owner of the bitch is entitled to a second breeding. So, if no pregnancy results, a free service will be given at the next heat of the same pre-approved bitch, and to the same stud, unless he is unavailable, or an alternative is mutually agreed upon. No refunds, sorry.
- Note: If the same stud dog is, for any reason, no longer available, an extension of the time necessary to fulfill the stud agreement will be given of two calendar years, and by then, another stud dog (*also owned by the owner of the current stud dog*) must be selected by the owner of the bitch. No refunds, sorry.
- No refund of stud fee will be given, sorry.
- Owner of the stud will sign the litter registration application upon clearance of payment for the stud service. If other terms are included in lieu of payment, or in addition to payment, these terms must be fulfilled before the litter registration application will be signed.
 - Other terms in lieu of payment: **None**
- No type of boarding costs will be charged, as long as the bitch is picked up within 1 week following notification of such need. Otherwise, a rate of \$10/day is required to be paid at the time of pick up. I know this may sound strange; but.... if, after 1 month, there is no response from owner of said bitch, or his/her designee (see Safety Plan below), she will be considered ‘abandoned’, and owner of the stud dog will be forced to take legal action, and possibly rehome her, after she has whelped (assuming breeding was successful).
- Any, and all, transportation/care expenses for the bitch are the responsibility of the owner of the bitch, or his/her designee (see Safety Plan).

Owner of the Bitch Agrees:

- No puppy resulting from this mating will be given or sold to any person or establishment dealing in the wholesaling or retailing of dogs or animals.
- All pets (*not conforming to the AKC standard*) resulting from this breeding will be sold on limited registration.
- The bitch is healthy, free of any communicable diseases, and is current on all vaccines.
- The owner of the bitch will be responsible for any type of veterinary care that may be required during the stay of the bitch, as well as after her stay, even if it is suspected that the bitch was exposed to any sort of disease, parasite, or even an Act of God during transport, or while visiting the residence of the stud dog owner.
- If any verified hereditary health defect should be present in any of the resulting puppies, the stud dog owner should be notified, as a courtesy.

Enforcement: If any suit or action shall be instituted to enforce or interpret this agreement, the prevailing party shall be entitled to recover from the losing party, in addition to statutory costs, such sums as all courts may adjudge as reasonable for the prevailing party's attorney fees in such suits, actions, or an appeal thereof. All action will take place in Clarion County, Clarion, PA.

In signing this, the Owner of the Bitch verifies that **all** members of his/her household are in agreement with the terms of this contract, as well. In other words, the Owner of the Bitch is the owner, and no changes will be made in the event that a co-owner, spouse, parent, roommate, or significant-other disagrees.
